

# Tournament Regulations Rhythmic Gymnastics

Organized by UKS Carramba



1. All documents needed to register for the competition are available on the website of UKS Carramba related to the competition: <https://www.carramba-rg.pl/carramba-cup> or sent to the Club registering for participation in the competition at its request in the form provided by it form.
2. Teams are registered for the Tournament by one selected person called team manager, only through this person the organizer arranges all formalities related to participation in the tournament.
3. The manager of the team gives the data of the coach, players, referee and, if the leading coach is not present at the competition, presents the organizer with the consent of the coach for the participation of the competitor he leads in the competition.
4. Applications for participation in the competition will be accepted until the cut-off date: 6 weeks before the date of the competition. Registration should be made via the KSIS system and on the appropriate form and sent to the e-mail address provided in the invitation.

Other forms of reporting are allowed. The organizer confirms the acceptance of the application from the group manager. In special cases, the organizer may allow competitors registered after the deadline to start. An absent competitor may be replaced by another, but the final number of competitors in the team must be consistent with the number of competitors reported to the organizer 4 weeks before the date of the competition, entry fees will not be refunded. For failure to appear at the competition, the organizer will charge a statutory penalty of 100% of the starting fee.

Children with a valid medical certificate to compete in rhythmic gymnastics competitions are allowed to participate in sports competitions. Each competitor must have a valid NW sports insurance. Licenses are not required, but having a license does not disqualify you from participating in the competition. The team manager, by registering his group, thus certifies that each competitor entered by him has a valid medical certificate and valid sports insurance.

5. Teams participate in the tournament at their own risk. The team manager, while registering the team for the competition, certifies that he has read the Competition Regulations.
6. All payments should be made to the organizer's account no later than 4 weeks before the date of the competition

The starting payment for all competitors is made by one joint transfer. Team manager with a club or private account. Confirmation of payment should be immediately sent by e-mail to the address provided in the invitation. The organizer may set a promotion for the entry fee paid before the date specified in advance. If the fee is paid to the organizer's account less than 14 days before the date of the tournament, the organizer charges the team with a statutory penalty for delay in payment of the entry fee of 100 euros.

7. The delegation should provide a judge with appropriate qualifications for the entire duration of the competition. If the organizer asks for it, the team manager is obliged to send the organizer a scan of the current judge's license (for licensed judges) and provide the date and place of the last training in which the judge participated, as well as the date and place of the judge's exam with an indication of the examiner.
8. By submitting the application, the team manager at the same time agrees to the processing of data of all members of his team in accordance with the club document "GDPR clause" after presenting them its content and expressing consent to the processing of their personal data on the principles set out in the above-mentioned document.
